# **COUNTY COMMISSION RECORD, CAMDEN COUNTY, MISSOURI**

# Thursday 05/02/2024

The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams.

### **Meeting Agenda**

Commissioner Williams made a motion to approve today's agenda. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye). Session opened at 10:00 A.M.

### **Prior Minutes**

Commissioner Williams made a motion to approve April 25, 2024 meeting minutes. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

#### New Business

**Discuss with citizen their request for the county to accept Turn Bridge Ct. as county road-** Casey Donahue (sp?) was present to speak on behalf of the purchaser of some lots along this road. He stated that the original intention for this road was that, once completed and paved, the county would accept the remainder of the road and it would form a full loop back to Turn Bridge Lane. The sale of this property is contingent on the county accepting this agreement. The purchaser will bring the section in question, which is about 330 feet of unfinished road, to county/state standards so it will be CART approved, and they will also pay to have this section paved. The Road and Bridge Administrator left the meeting to look for information concerning this road in the County Clerk's Office. At 10:15 A.M., Commissioner Williams made a motion to table this item on the agenda until the Road and Bridge Administrator returns to the meeting. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Annual Limited License Agreement for Mapping Solutions- Commissioner Williams made a motion to approve this licensing agreement for 2024. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

**Sheriff- Agreement for Security Deputies' Services for 2024- Shady Gators-** There is a difference in pay for the deputies' services. This year, they'll receive \$75.00 per hour versus \$65.00 which was the prior rate. Commissioner Williams made a motion to approve this agreement between the Sheriff's Department and 7MM Cove. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

Discuss 2022 Financial Audit findings- Camden County Auditor, Jimmy Laughlin, was present. He stated that there were minimal findings (recommendations) within the financial audit but nothing major that hinders the county's ability to move forward with the 2023 financial audit. Some items that were found was that Camden County was late in sending out the 2022 Federal Expenditure letter, there were some discrepancies with the water/sewer districts and their debt financing that had to be worked out, and the reporting for Workman's Comp. was late as well. Other than that, Camden County is on track for meeting all of the time goals for this year. There were no motions made on this agenda item. **\*The Camden County Auditor stated this information would be uploaded to the county website\*** 

**Discuss Camden County's \$1,000 contribution to the National Center for Public Lands Counties-** Commissioner Williams stated that this entity and what they represent is not relevant to Camden County, and Commissioner Skelton made a motion to not pay \$1,000.00 to the National Center for Public Lands Counties. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Gohagan (aye).

**April 2024 Tax Abatements-** Commissioenr Gohagan made a motion to approve the April 2024 tax abatements tentatively approved by an employee of the Camden County Commission Office. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).

**Discuss with citizen their request for the county to accept Turn Bridge Ct. as county road-** Commissioner Gohagan made a motion to accept this portion of Turn Bridge Court once the road is in accordance with Road and Bridge specifications and requirements. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).

**Adjourn:** With no further official business on the agenda, Commissioner Williams made a motion to adjourn to any unofficial business that may develop during the day. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye). Session closed at 10:34 A.M.
