## New Business

**LEST Budget Amendment-** Newton County reimbursed Camden County \$413.96 for glass that was damaged during transport. That money has to be moved from the LEST budget to reimburse the maintenance line it was initially taken from. Commissioner Williams made a motion to approve the budget amendment from LEST to maintenance for \$413.96. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Williams (aye) and Commissioner Gohagan (aye).

**Sewer Board Apt.-Annette Richards-** Commissioner Gohagan made a motion to appoint Annette Richards to the Camden County Sewer Board to fulfill the remainder of Don Murphy's term. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).

**Annual CART Funds Distribution to Horseshoe Bend Special Road District- The 2023 CART Fund reimbursement to Horseshoe Bend Special Road District is \$414,494.71. Commissioner Gohagan made a motion to approve the \$414,494.71 CART Fund distribution to Horseshoe Bend Special Road District. Commissioner Williams seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Williams (aye).**


