The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan, and Second District Commissioner Don Williams was absent.

Meeting Agenda

Commissioner Gohagan made a motion to approve today's agenda.

Commissioner Skelton seconded the motion. The motion passed by vote:

Commissioner Gohagan (aye) and Commissioner Skelton (aye). Session opened at 10:02 A.M.

Prior Minutes

Commissioner Gohagan made a motion to approve June 25, 2024 meeting minutes. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye).

New Business

Bid Award 240625 Assessor's Annex Building- Siding- Commissioner Skelton made a motion to accept the bid from The Wright Roofing Company upon the recommendation of the Camden County Assessor. Commissioner Gohagan seconded the motion. The motion passed by vote: Commissioner Skelton (aye) and Commissioner Gohagan (aye).

Bid Opening- 240627 Post Office Outer Remodel- The Camden County Commission advised the maintenance department to put out an invitation to bid to see what it would cost to remodel/replace the front entry of the old post office building. There were two bids received: Camdenton Glass and TMS Contracting. The head of maintenance stated they were trying to get a rough estimate of what it might cost to get this work done, but it might not occur until next year or later.

Commissioner Skelton made a motion to table this bid opening indefinitely.

Commissioner Gohagan seconded the motion. The motion passed by vote:

Lodging Tax- Commissioner Skelton asked Ms. Laura Salamun to come forward and give a brief overview of the lawsuit regarding lodging tax being collected and distributed to the TCLA/business districts. At this time, there has been no direction on handling existing funds or advise to property managers/owners who have collected any taxes in advance. No lodging tax should be collected after June 25, 2024. There were no motions made on this agenda item.

Sheriff's Dept. Firearms Inventory Discussion- According to Camden County Auditor, Jimmy Laughlin, a formal inventory has not taken place for a long time, but he is working with his employees to get this completed. As for the Sheriff's Department, inventory is almost complete; they're waiting for numbers from reserves. County-wide inventory was discussed- the possibility of having some kind of scan system that would require everything to have a barcode on it. Commissioner Skelton inquired about some inventoried items that he was able to see. It was acknowledged by the Sheriff that there are probably many things in his possession that no longer work or have not been used for a long time. They discussed auctioning those items. There were no motions made on this agenda item.

Resolution- Public Admin. Conservator Funds- Commissioner Skelton read the draft of Ordinance 06272024 aloud. Commissioner Gohagan made a motion to ammend the ordinance to direct the funds to Buildings & Grounds instead of General County Revenue. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye).
