The Camden County Commission met with Presiding Commissioner Ike Skelton, First District Commissioner James Gohagan and Second District Commissioner Don Williams was absent.

#### **Meeting Agenda**

Commissioner Gohagan made a motion to approve today's meeting agenda. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye). Session opened at 10:00 A.M.

## **Prior Minutes**

Commissioner Gohagan made a motion to approve Thursday's meeting minutes [10-24-24]. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye).

## New Business

**Gilmore & Bell- bonding agency renewal agreement for services-** Commissioner Gohagan made a motion to approve the Gilmore & Bell contract for bonding services. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye).

Southwest Missouri Forensics II, LLC. 2025 Medical Examiner services for Camden County- There is no price increase for the 2025 medical examiner services to Camden County from the 2024 contract: \$400,000.00. Commissioner Gohagan made a motion to approve the medical examiner contract with Southwest Forensics. Commissioner Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye). **Elliott Data Systems- card readers-** Previously, the Sheriff's Department and commissioners discussed paying for new card readers and a security system through Elliott Data out of LEST building and grounds funds. Commissioner Skelton reiterated that funds have been allocated for this. Originally, the quote was around \$90,000 but had been reduced to approximately \$77,100 when the Sheriff's Department decided not to replace some cameras. It was stated that the estimated amount of card readers being replaced may increase slightly because some card readers had been missed in the original count. There were no motions made on this agenda item.

#### **Old Business**

**UTV Ordinance-** Commissioner Skelton asked everyone in the room if they had any other input or suggestions regarding drafting an ordinance for Camden County. Shawn Kobel with the Sheriff's Department had sent over several different pieces of information from other counties that have already created ordinances for UTV use on their county roads. There were no motions made.

**LEST II Trust Fund-** Commissioner Skelton asked for an update from the County Auditor. Jimmy Laughlin stated he was still working on this along with the County Counselor. He stated that he was hopeful to have something prepared in a couple of weeks. There were no motions made.

**Inventory-** Commissioner Skelton asked the County Auditor for an update on the inventory of county offices. He stated his office is still actively working to complete inventory. There were no motions made.
