McGrath Insurance- Discuss County Prescription Drug Plan- The county's insurance broker was present to discuss moving Camden County back to Express Scripts from Script Care due to the cost the county has incurred since switching plans in 2024. Commissioner Gohagan made a motion to move Camden County's drug prescription plan back to Express Scripts under option 3. Commissioner

Skelton seconded the motion. The motion passed by vote: Commissioner Gohagan (aye) and Commissioner Skelton (aye).

## **Other/Old Business**

**Tunnel Dam Update-** Commissioner Skelton is attending a NACO Legislative Conference in March of 2025 and requested a meeting with FERC to discuss Tunnel Dam. An update from FERC was received Thursday morning stating that conversation would have to be limited in regard to Tunnel Dam since it is an ongoing matter. There has been no final resolve on this matter. There were no motions made.

**LEST II Trust Account-** Sheriff Tony Helms requested an update regarding separation of LEST II funds from all other LEST funds. Jimmy Laughlin (Auditor) stated he is currently focusing on completing Tony's inventory of the Sheriff's Department before he retires at the end of the year and finalization of the 2025 county budget so he has not began the LEST II fund separation process. There were no motions made.
